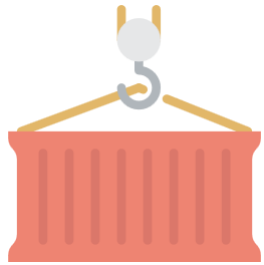

PHISYCAL & DOCUMENT HANDLING

- Build up /Break down pallets
- Physical inventory of ULD stock and loading equipment, updating daily or weekly records
- Physical inventory of freight, daily or weekly records



PHISYCAL & DOCUMENTAL HANDLING

- Cargo acceptance and storage
- Freight and Document (awb, customs documents, check sheet, attached declarations) checks
- Issue of cargo manifest, awb and other flight documentation
- AVI, VAL, ADR Checks



PHISYCAL & DOCUMENT HANDLING

- Forwarding FFM messages, pre alert, non compliance messages
- Arrange freight when accepted with irregularities
- Check of loading compatibility between cargo and holds



- Booking shipments
- Re-booking shipments in case of missing flight
- Notification of offloading



- Booking or deletion of truck services
- Airlines fees collection and Monthly statement of accounts



- Notification of arrival of shipments
- Release of documents and Customs clearance information
- “Missing cargo” and “found cargo” messages



The **Fast Customs Clearance Centre** was recently set up and includes a system developed by FFM that allows both the aviation sector and government bodies – Customs - to determine whether a shipment will require prior inspection at Bologna Airport based on electronic pre-departure and pre-arrival info.

Clients of Fast Freight Marconi's Customs Clearance Centre will have their freight ready to deliver in **4 hours' time after arrival** (against previous average of 2/3 days)



Air freight is based on the 'known shipper' principle: freight has to be declared.



For this reason Airports and flight Operators are facing increasingly stringent security requirements, which necessitate a complete check of the freight for any dangerous elements.



X-ray inspections of pre-packed ULDs thus constitute a major intervention in the work flow in the cargo handling process



FFM has recently obtained the Italian Transport Ministry Authority's (ENAC) Certification for "Agente Regolamentato" (Known Shipper)



Warehouses

- 5.000 sqm of warehouse space, both for inbound & outbound cargo equipped with refrigeration units, cells for live animals and corpse storage facilities
- radiogenic checking machines for security screening

Equipment

- cargo loader (main-lower deck)
- packing & unpacking, moving & stocking equipment for pallets and unit loads
- 2 automatic platforms, one 10 feet long and the other 20
 - 7 docks for loading and unloading trucks
 - forklifts for loads from 20.000 to 80.000 Kilos
- Completely automated management of all inbound & outbound freight using bar code readers





All our staff are trained according to IATA standards and DGR IATA certified

They are trained to manage AVI, perishables and in issuing ADR documents in accordance with road transport requirements
